Treasurer's Report 2020/21

Annual Accounts

The Club's Accounts for the year ended 30th June 2021 have been independently examined and are presented for formal agreement. Copies are available from the Treasurer.

Income & Expenditure

Total regular income of the Club changed because the annual grant from the Mercers' Company has now ceased and because we received a bequest of £7,200. Annual subscriptions continued at a lower level than previously.

Expenditure decreased substantially because there have been no events during the year, the remaining costs being mainly for insurance, the website and sundry office costs.

The overall result is a surplus of £6,464.

Balance Sheet.

The Balance Sheet now consists mainly of the bank account and a stock of menu cards, etc for use at the final lunch in September 2021. The separate uninvested life funds account has now been merged with the general fund.

Present Financial position

The Club has assets at the balance sheet date consisting almost entirely of cash deposits totalling £17,934. This is substantially more than had ever been anticipated both because there have been no activities and because of the unexpected bequest.

During the final few months of the Club, some of this money will have been spent on subsidies for the President's Reception and for the AGM, but some funds will remain after closure. A decision needs to be made as to what should happen to these funds.

Summary

The accounts have been independently examined and the Treasurer is very grateful to Old Mercer Colin Ellis for his diligence.

The acceptance of the accounts is commended to you.
